It was reported that the city of Bethlehem will be sending contracts to the groups performing at the Rose Garden this summer and that each band will be paid directly from the city.

The possibility of insurance to protect the local from lawsuits such as the one we are currently involved in was discussed. We will check with other locals to determine if they have such a policy and check with several insurance agencies to determine the cost.

The resignation of Tess Varley was accepted upon motion of Krasley and Heiney.
